If there is no native title party at the end of the four months after the notification day (i.e. **8 February 2026**) then the mining lease/s may be renewed.





The mining lease may be renewed if, by the end of the period of four months after the notification day (i.e. 8 February 2026), there is no native title party under section 30 of the Native Title Act 1993 (Cth) in relation to the area of the application for renewal. 
