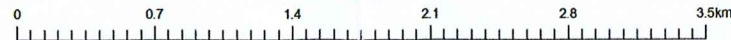


Locality Map

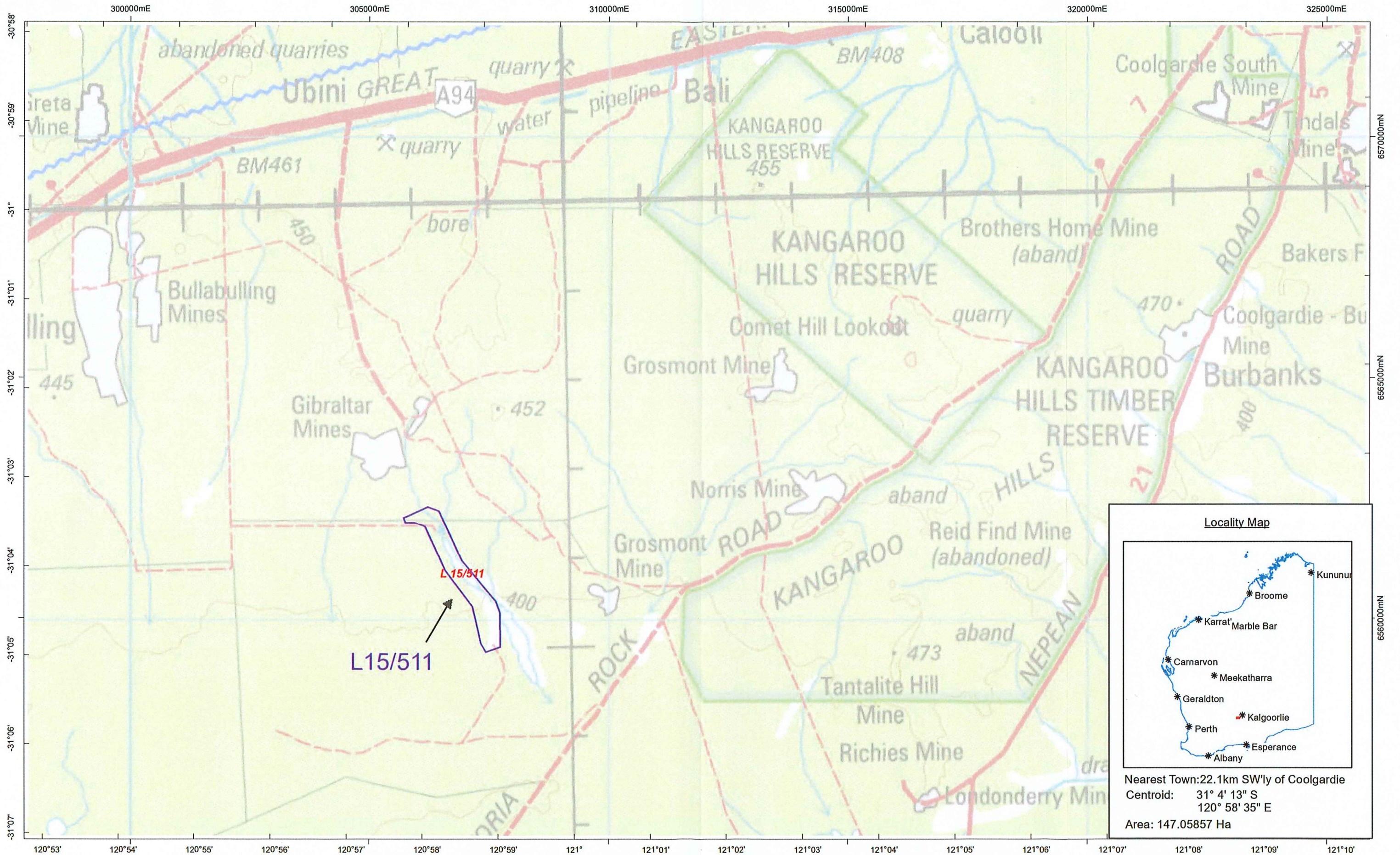
