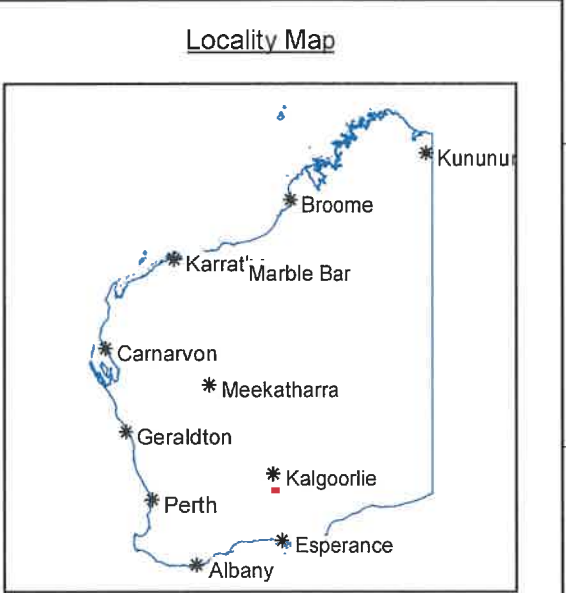
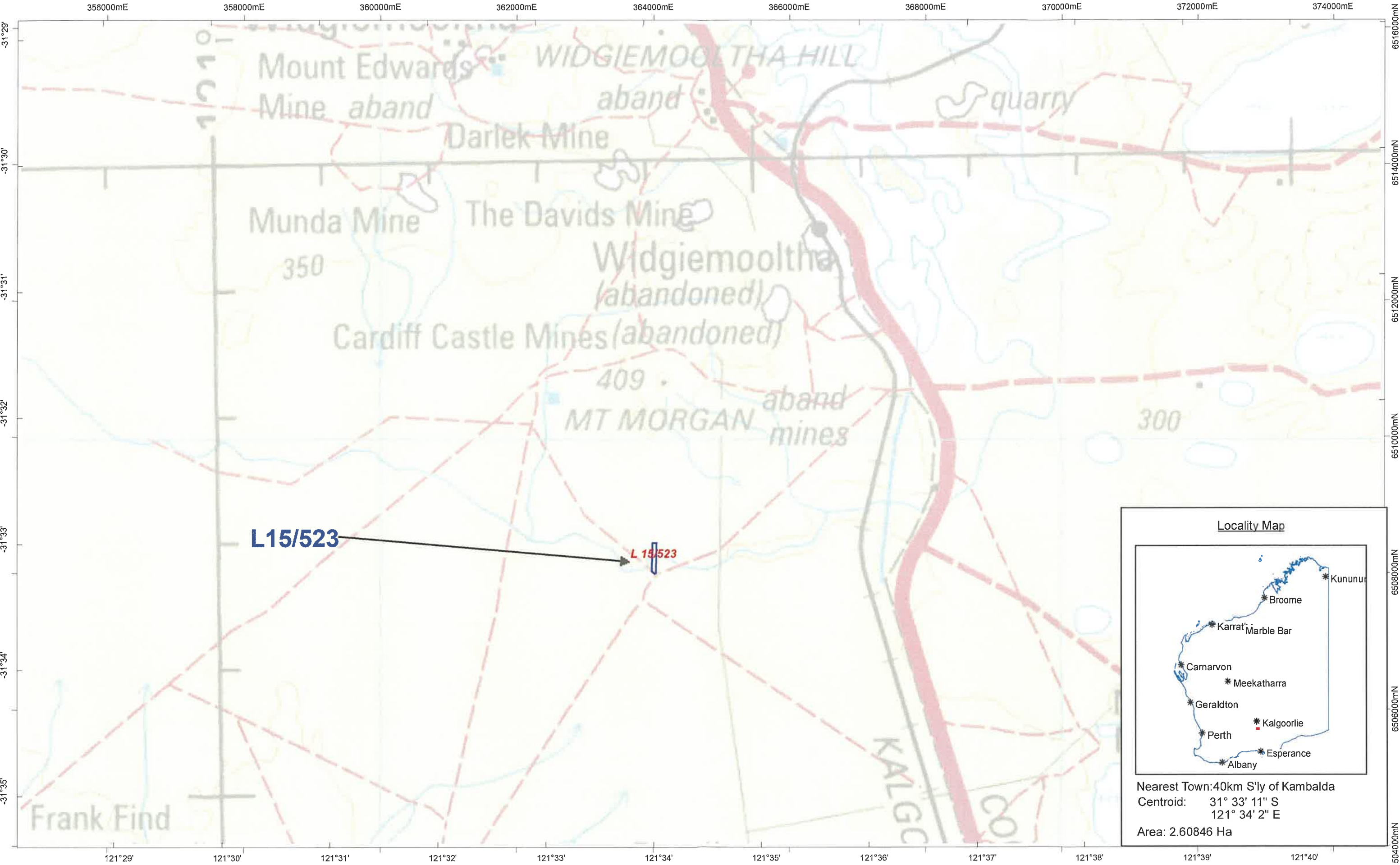

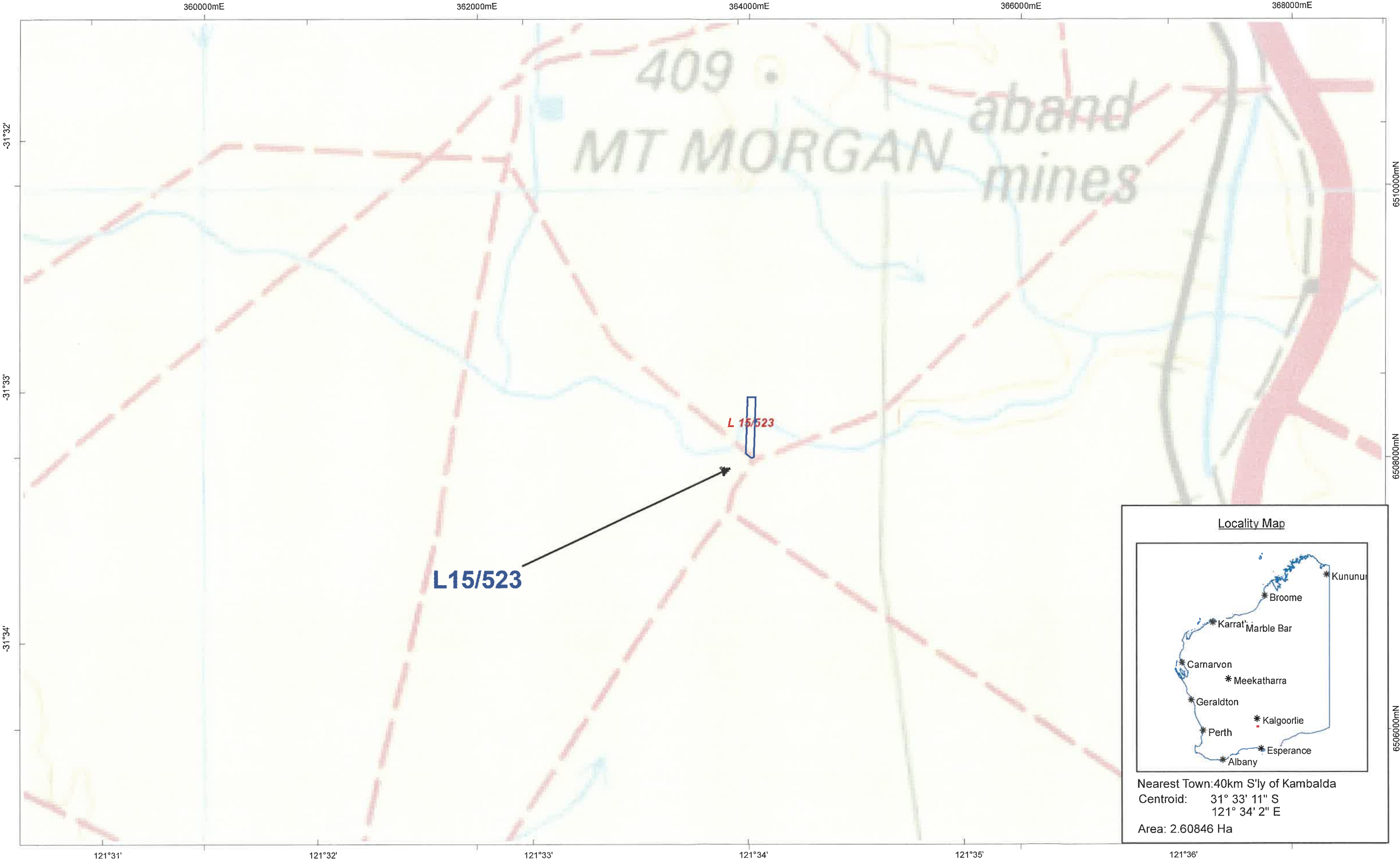

Locality Map

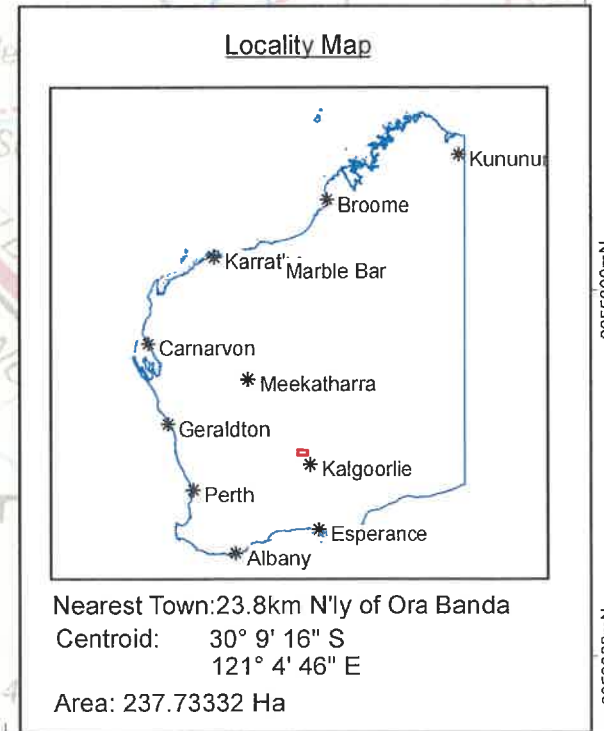
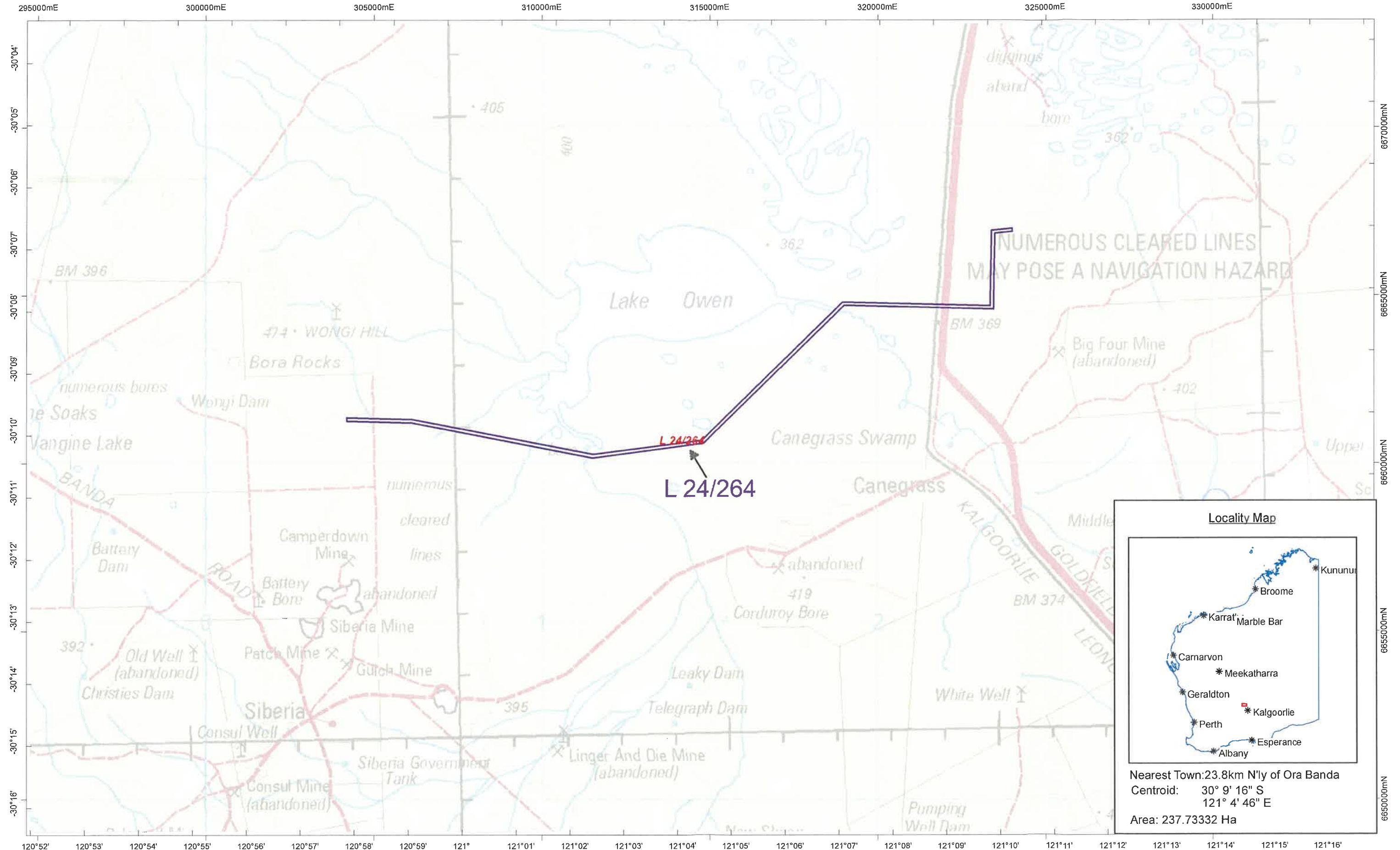

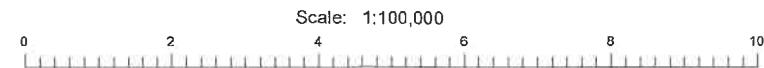
