In accordance with section 29(2) of the *Native Title Act 1993 (Cth)* (NTA) the Department of Mines, Petroleum and Exploration (DMPE) provides this notice and a plan showing the location of lease/licence application/s that under the *Mining Act 1978 (WA)* may be granted over land and/or waters in respect of which you are a Native Title representative body. Arrangements have been made to publish this notice in newspapers (including newspapers catering mainly or exclusively for the [interests](#) of [Aboriginal peoples](#) or [Torres Strait Islanders](#)).

The DMPE hereby advises that the "notification day" is **12 August 2026**. This date is given in accordance with section 29(4)(a) of the NTA.

Under section 30(1)(a)(i)(ii) of the NTA, any person who, four months after the notification day, is a registered native title claimant in relation to any of the land or waters that will be affected by the act becomes a native title party and is entitled to a procedural right to negotiate in accordance with section 31 of the NTA. The four-month period ends on **12 December 2026**.

If there is no native title party at the end of the four months after the notification day then the lease/licence application/s may be granted.

NOTICE TO GRANT MINING TENEMENTS
NATIVE TITLE ACT 1993 (CTH) SECTION 29

The State of Western Australia HEREBY GIVES NOTICE that the Minister for Mines and Petroleum, C/- Department of Mines, Petroleum and Exploration, 100 Plain Street, East Perth WA 6004 may grant the following tenement applications under the *Mining Act 1978*:

Nature of the act: Grant of mining leases, which authorises the applicant to mine for minerals for a term of 21 years from notification of grant and a right of renewal for 21 years.

Notification day: 12 August 2026

Native title parties: Under section 30 of the *Native Title Act 1993 (Cth)*, persons have until 3 months after the notification day to take certain steps to become native title parties in relation to applications. The 3 month period closes on **12 November 2026**. Any person who is, or becomes a native title party, is entitled to the negotiation and/or procedural rights provided in Part 2 Division 3 Subdivision P of *Native Title Act 1993 (Cth)*. Enquiries in relation to filing a native title determination application to become a native title party should be directed to the Federal Court of Australia, 1 Victoria Avenue, Perth WA 6000, telephone (08) 9268 7100. The mining tenements may be granted if, by the end of the period of 4 months after the notification day (**i.e. 12 December 2026**), there is no native title party under section 30 of the *Native Title Act 1993 (Cth)* in relation to the area of the mining tenements.
